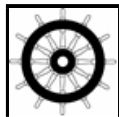

Are decorative floor carpets, tufted from a yarn material of 100% wool with 100% polyester acoustic backing. The product was applied on the calcium silicate board by means of ege 90RH adhesive.

Approved for all colour variations.

Maximum organic content: approx. 45%

Any adhesive used, other than the one used during testing, has to be tested for low flame spread characteristics according to IMO 2010 FTP Code part 5 and to be approved according to the Marine Equipment Directive and bear the MED Mark of Conformity.
